ARTICLE 1 - OBJECT

As a provider of internet access, Mobile Vikings nv, hereinafter referred to as "Mobile Vikings", gives its Vikings the opportunity to consult and disseminate a mass of public, private, commercial and non-commercial information. In order to efficiently frame the sometimes conflicting interests of internet users, Mobile Vikings has drawn up Terms of Use as an annex to its General Terms and Conditions. This document constitutes a code of conduct, describing the rights, obligations and responsibilities of the Viking as an internet user.

ARTICLE 2 - ACCEPTANCE OF THE TERMS

By the mere fact of using his/her internet connection, the Viking accepts to comply with these Terms of Use.

ARTICLE 3 - RULES OF USE APPLICABLE TO INTERNET SURFING

3.1. The Viking commits to:

- refraining from acts of computer piracy, cracking or hacking of the Mobile Vikings system or any other system;
- not unlawfully accessing, altering or destroying the data of the connected networks in any way;
- not disrupting the proper functioning, accessibility, use or performance of the Service by generating significant volumes of traffic (flooding);
- not distributing any malicious software (malware) with the intention of damaging the integrity of the information systems and/or the data on those systems or with the intention of fraudulently gaining access to confidential information.

3.2. The Viking is requested to report any content that he/she considers illegal or harmful. He/she may address the author of the content in question, the internet user who published the content or the competent authorities.

ARTICLE 4 - RULES OF USE FOR THE CREATION AND/OR DISTRIBUTION OF CONTENT ON THE INTERNET

4.1. The Viking commits to:

- not publishing content that is contrary to good morals, public order or the law in force or that can be considered as an incitement to commit crimes;
- not publishing content that infringes on the intellectual property rights of third parties;
- not publishing content that infringes on the privacy or good name of third parties;
- not publishing content that is insulting, derogatory, threatening, defamatory or indecent towards anyone;
- not publishing content that is racist, xenophobic or revisionist in nature or which incites discrimination, hatred or violence against a person because of their ethnic origin, religion, sexual orientation, skin colour, descent or nationality;
- not publishing content (text, video, hyperlinks, etc.) (on social media, blogs, comments to blogs, portals, websites) that advocates dangerous behaviour and/or gives instructions to achieve a dangerous goal (e.g. the manufacture of explosives or harmful substances, self-mutilation, anorexia, bulimia, binge drinking, etc.);
- not advertising services of a sexual nature;
- not posting messages on blogs or discussion forums that are not related to the subject of the blog or forum in question and whose only purpose is to harass the blogger, the forum owner and/or its visitors;
- not publishing or posting content that is not guaranteed to be free of viruses.

4.2. The Viking is solely liable, towards Mobile Vikings and third parties, for the content he/she publishes on the internet (including, among others, software, hyperlinks, files that are defective or affected by a virus) and the possible harmful consequences of that publication.

4.3. The content published by the Viking must not only comply with the General Terms and Conditions and the principles set out in these Terms of Use, but must also be regularly updated (in particular if the content contains criticism regarding the activities of third parties).
